## **Understanding Digital Nomads**

The term digital nomad was coined in 1997 in a book called The Digital Nomad, written by Tsugio Makimoto and David Manners. Their book prophesized the invention of a singular, all-powerful communication device that would allow employees the ability to work from anywhere, among other hypotheses.

Digital nomads are individuals who want to have freedom and flexibility with the jobs and time to travel. They get to explore new cultures by putting down temporary roots in many locations each year, as they are people who are location-independent and use technology to perform their job, living a nomadic lifestyle. Digital nomads work remotely by telecommunication rather than being physically present at a their company's headquarters or office. The digital nomad lifestyle has been made possible through several innovations, including content management software, cheap Internet access through WiFi, and smartphones to contact clients and employers, and they use their skills to work via laptops, social media, and mobile phones and may work out of cafes, beaches, or hotel rooms.

- Ability to open a bank account in a local financial institution.
- Foreign driver's license recognition throughout the term of the visa.

# **Requirements for Costa Rican Digital Nomad VISA**

#### Main Applicant:

- Application Form duly signed and payment of application fee (US\$ 100).
- Copy of passport containing biographical with information and entry seal
- Proof that salary is generated abroad and there is not an income source in Costa Rica.
- Proof of a stable income of US\$ 3,000 or US\$ 4,000 in case dependents are included in the form of 12-month bank account statements, along with a signed affidavit, showing proof of the same.
- Special Power of Attorney, if needed

## **Dependents:**

- Children under 25 years old: Birth Certificate
- Children over 25 years old with special needs: Medical Criteria / Epicrisis
- Spouse: Marriage Certificate with less than 6 months of issuance.
- Common-Law Partner: Document that confirms declaration or acknowledgment of Common-Law Union.
- Senior Adults: Affidavit confirming the bond or coexistence with the applicant.
